# PEACE, POWER-SHARING AND CITIZEN INCLUSION: COMPARATIVE PERSPECTIVES FOR KANAKY AND/OR NEW CALEDONIA

## PRESENTATION

After more than thirty years of institutional peace following the Matignon–Oudinot and Nouméa Accords, New Caledonia remains a deeply divided society. The self-determination referendums (2018–2021) and the violence of May 2024 highlighted the persistence of community divisions and the limitations of the current governance model.

This conference will bring together local and international speakers who are specialists in comparative law and power sharing in divided societies. Drawing on their experiences in Northern Ireland, Bosnia–Herzegovina and Mindanao (Philippines), they will offer a comparative perspective on the consociational institutional mechanisms put in place to preserve peace and organise coexistence.

Particular focus will be given to the case of Kanaky and/or New Caledonia, with the presentation to the general public of the results of a quantitative survey of 1,200 people. While confirming the depth of the divisions, this study also reveals the existence of unprecedented margins for compromise.

At a time of major statutory change, this conference aims to contribute to the public debate on the institutional future of the country.
